NAV increases by 0.6% in April

- Princess Private Equity Holding Limited's (Princess) net asset value increased by 0.6% to EUR 11.57 per share
- Portfolio developments (+0.8%) were positive and currency movements flat
- Princess received distributions of EUR 8.1 million and invested EUR 9.0 million during the month

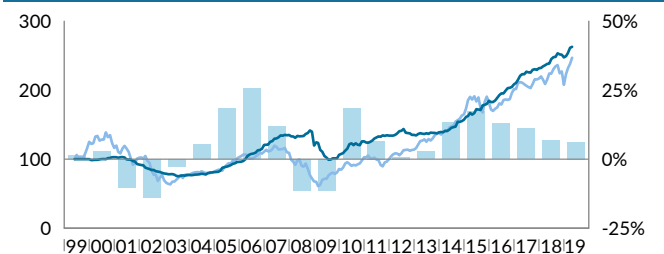
Princess received distributions of EUR 8.1 million during the month, of which EUR 4.1 million stemmed from the mature legacy fund portfolio.

Princess invested a total of EUR 9.0 million during the month, of which EUR 8.9 million was invested in Project Fox, a direct equity investment in a newly formed specialty property and casualty insurer and reinsurer focused on complex risks for commercial clients. Based in London and Bermuda, the company will be led by a team of risk experts with over 30 years of industry experience. The company will write specialty risk and reinsurance policies in areas including property, casualty, and others, taking advantage of an increasingly attractive market environment. Going forward, the company will focus on building up its underwriting team to expand its capacity and further develop effective underwriting strategies.

The portfolio includes direct, primary and secondary fund investments. Princess aims to provide shareholders with long-term capital growth as well as an attractive dividend yield. The shares are traded on the Main Market of the London Stock Exchange.

The Board of Directors of Princess passed a resolution to implement a share buyback program on 13 December 2010. During April 2019, 0 shares were repurchased under the share buyback program. As of 30 April 2019, there were 69'151'168 shares outstanding, and the NAV was thus calculated based on a total of 69'151'168 shares outstanding.

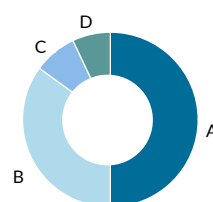

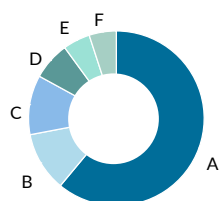

Investments by regional focus



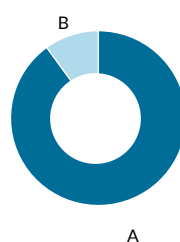
