NAV increases by 0.6% in August

- Net asset value increased by 0.6% to EUR 14.98 per share
- Value creation in the portfolio (+0.3%) and currency movements (+0.7%)
- Princess received distributions of EUR 5.2 million

During the month Princess received distributions of EUR 5.2 million, of which EUR 2.7 million stemmed from a loan repayment made by Esentia (formerly Fermaca), a leading player in the energy sector in Mexico. Esentia develops, constructs, owns and operates natural gas pipelines and other related energy assets. The majority of its pipeline capacity is contracted under long-term take-or-pay transportation agreements with creditworthy counterparties, providing the business with stable and predictable cash flows. The remaining balance of EUR 2.5 million was predominantly received from Princess' mature legacy fund portfolio.





Investments by regional focus




